Governor Dayton appointed **Sara R. Grewing** and **Nicole J. Starr** as District Court Judges in Minnesota's Second Judicial District. Ms. Grewing and Ms. Starr will be replacing the Honorable Paulette K. Flynn and the Honorable Gregg E. Johnson, who retired earlier this year. The judges of the Minnesota Tax Court announced that, effective January 5, 2015, **Joanne H. Turner** has been elected Chief Judge of the court. Before her appointment to the Tax Court, Turner was of counsel to the Minnesota Supreme Court. From 1993 to 2005, she was an attorney in private practice with the Minneapolis law firm of Mackall, Crounse & Moore, where she was a member of its Board of Governors. Before her admission to the bar, Turner was an Assistant Professor of Accounting and Taxation at The Ohio State University and the Rochester Institute of Technology in Rochester, New York.

Governor Dayton reappointed the **Honorable Bradford Delapena** as Judge of the Minnesota Tax Court. Judge Delapena is appointed to a six year term, which will expire on January 4, 2021.
